Brief Proceedings of the 25th Annual General Meeting of the Company

The 25th Annual General Meeting of the members of the Company was held on Tuesday, September 29, 2020 at 11:00 a.m. at the Registered Office of the Company situated at 122 I, Silver Rock Apartment, 2nd Floor, Venkatasamy Road West, R.S.Puram, Coimbatore – 641002.

The Meeting commenced at 11:00 a.m. and concluded at 12:15 p.m.

Mr. Ramesh Chand Bafna, Managing Director of the Company chaired the Meeting.

The requisite quorum being present, the Chairman declared the meeting to be in order and initiated the proceedings of the meeting.

The Chairman welcomed the members to the 25th Annual General Meeting of the Company.

All the Directors of the Company were present at the meeting except Mr. Jitendra Kumar Jain, Independent Director who was unable to attend the meeting due to his prior commitment.



The Chairman informed that with the permission of the members present at the meeting, the following having been already circulated, were taken as read:

- a) the 25th Annual General Meeting Notice, the Directors' Report with the Annexures thereto, the Annual Standalone Financial Statements for the financial year ended March 31, 2020;
- b) the Unqualified Statutory Auditor's Report for the financial year ended March 31, 2020 and
- c) the Unqualified Secretarial Auditor's Report for the financial year ended March 31, 2020.

The Chairman informed that there was no qualification or adverse remark in the Statutory Auditors Report and the Secretarial Auditors Report for the financial year ended March 31, 2020.

The Chairman commenced his speech and gave an overview on the performance of the Company for the financial year ended March 31, 2020.

The Chairman invited the shareholders to express their views and ask questions, if any.

The queries raised by the members were suitably addressed by the Chairman and Mr. Kalpesh Bafna, Wholetime Director of the Company.

The Chairman informed the members that the Company had engaged the services of CDSL as the agency to provide remote e-voting facility.



The Chairman informed that the Company had provided the remote e-voting facility to all the members to cast their vote electronically on all the resolutions set forth in the notice of the AGM. He further informed that the remote e-voting period had commenced on Saturday, September 26, 2020 at 9:00 a.m. (IST) and had ended on Monday, September 28, 2020 at 5:00 p.m. (IST).

The Chairman informed the members that the facility to vote through ballot paper had been provided at the venue of the AGM. The Chairman informed that the members present at the meeting and who had not already cast their vote through remote e-voting, could cast their vote through ballot paper and deposit it in the ballot box kept at the venue of the AGM.

The Chairman informed that the Board of Directors have appointed Mr. R Ramchandrar of M/s. R Ramchandrar & Associates, Company Secretaries, as the Scrutiniser to scrutinise the remote e-voting and the voting by the use of ballot paper at the AGM, in a fair and transparent manner.

The Chairman informed that the Scrutiniser shall submit a consolidated scrutinisers report, not later than 48 hours of the conclusion of the AGM. The voting results and the Report of the Scrutiniser shall be placed on the website of the Company at www.mounthousing.com and on the website of CDSL at www.evotingindia.com and shall be communicated to the Stock Exchange i.e BSE Limited.

The Chairman concluded his speech by placing on record his appreciation and gratitude for all the stakeholders for having reposed their trust and confidence in the Company.

The Chairman thanked the Shareholders, Directors, Senior Management and Auditors for joining the meeting and declared the meeting as concluded.
